Dr Gallen had an unexpectant walk in of a baby brought to the surgery who had been severely injured by its father. She assessed the baby incredibly thoroughly, took photos to share of the injuries, that led to the immediate arrest of the baby's father. Dr Gallen then phoned for an ambulance for rapid conveyance. The ambulance took

some time, necessitating a further call to escalate, and during this time she was the only doctor in the practice. Dr Gallen performed 10 minute observations on the baby for over 2 hours.

In domestic abuse, up to 44% of victims report having been strangled. In sexual violence, 1 in 11 adults reporting rape also describe strangulation as part of the assault.

DOMESTIC ABUSE EXTRA SUPPLEMENT

The following pages are dedicated to information and updates related to Domestic Abuse.

The ICB Domestic Abuse Policy has recently been revised and can be found here: Domestic Abuse - NHS Somerset

This policy has been significantly rewritten to reflect recent legislative changes and to ensure that it is a useful template for providers within primary care. A separate

SOP has also been produced that sets out the practical procedural steps to take, with associated specific support and guidance documents also included. See attached.

Domestic Homicide Review (DHR) updates:

SafeLives, a domestic abuse charity, has set out a series of statistics regarding the health impacts of domestic abuse:

- 80% of women in a violent relationship seek help from health services, usually GPs, at least once. This may be their first or only contact with professionals.
- 30% of domestic abuse starts and/or escalates during pregnancy.

The Department of Health reports the NHS spends more time dealing with the impact of violence against women and children than "almost any other agency".

There are currently 21 open DHR cases in Somerset. Key learning themes for all agencies involved (including Primary Care) can be found in the attached document, as well as other information about Domestic Abuse and DHRs.

Domestic abuse and Acquired Brain Injury:

The CEO at Headway Somerset gave a presentation at the Somerset

Domestic Abuse Board, outlining the role of the organisation.

At the presentation it was highlighted that over the last couple of years more people are disclosing their acquired brain injury is related to domestic abuse. There are around 8-9000 people with acquired brain injuries (ABI) every year in Somerset. Of those, 1500-1600 brain injuries are related to stroke. Over 5000 non-admissions of people presenting at Emergency Department. The definition of an ABI is a brain injury after birth and doesn't include hereditary disorders /illnesses. Many victims through the research highlight concerns over disclosing that they have experienced an ABI, including perpetrators using the injury against them, or within issues with child custody/contact. Launch of expanded domestic abuse service for litigants in person. A Healthy and Caring Somerset

The team at Citizens Advice Taunton have expanded to help more survivors of domestic abuse and violence in Somerset. The Litigants in Person (LiP) service will help survivors not eligible for Legal Aid, understand their rights around issues such as divorce and child arrangements.
