Are you a Primary Care professional looking to supervise learners within your practice or PCN?

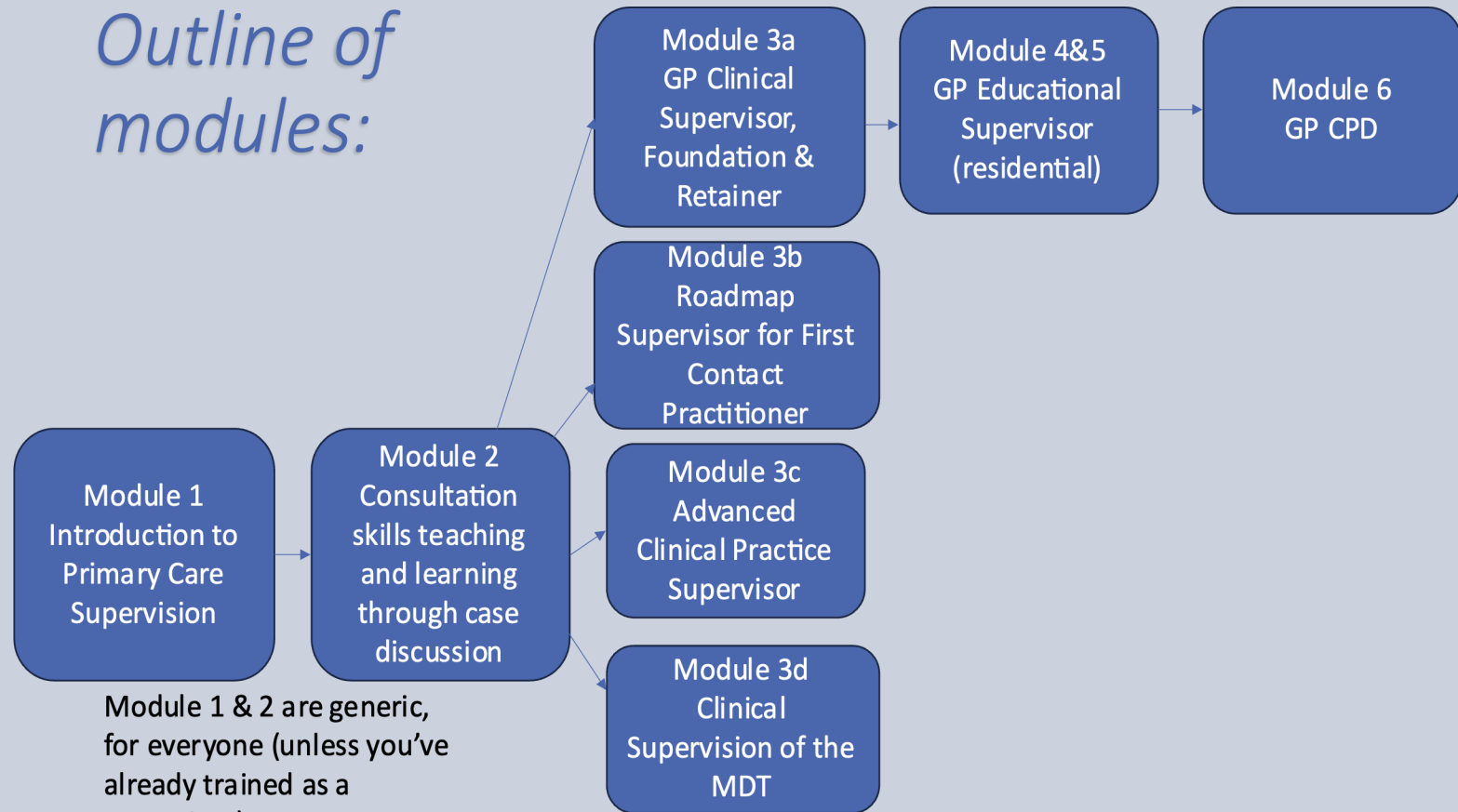
The MMSC is a modular course designed for you to get the training you need to supervise other professionals in your practice.

MMSC Overview

- It is designed for a range of primary care health professionals to learn what they need to successfully supervise various learners.
- Each module is half a day, delivered in small groups on -line by experienced facilitators.
- The course has grown from the successful GP trainer course and the Roadmap Supervisor's course, to streamline and simplify supervisor training in the South West.
- It is supported by practical on-line resources.

Entry Criteria

Entry criteria for Allied Health Professionals and Nurses to enrol on Module 1+2

All Participants must

- Process a Post Graduate cert (60 credits) in advanced practice or equivalent.

And

- Hold a position as a Consultant Practitioner, Advanced Practitioner, or be verified as a First Contact Practitioner.

And

- Experienced or actively practicing in the area they intend to supervise.

And

- Have a minimum of one year of experience working in the specific area of supervision.

Entry Criteria

You have the choice to either complete Module 3b or 3c independently if you meet the following criteria

- Be a GP Clinical or Educational Supervisor
or
- Be a RMSV - wish for a refresher
or
- Has completed Module 1 + 2 of the MMSC

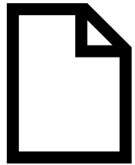

Structure and Content

- Support and maintain trainee well-being
- Coach a trainee AP to identify learning needs
- Assist with creating development
- Coach a trainee Advanced Practitioner
- Explain the importance of interpreting MSc level course content
- Recognise the importance of organisational cultural considerations for Advanced Practice.
- Utilise learning outcomes 1-7 to evaluate and appraise a trainee's ability to deliver an Advanced Practice level service.
